

### **Recall Description**

General Motors has decided that certain vehicles listed above may not conform to sections (19), (28), and (30)(c) of Canada Motor Vehicle

Safety Standard (CMVSS) No. 108, "Lighting Systems and Reflective Devices". The standard requires daytime running lights (DRLs) to be active if the vehicles are operated at the prescribed speed or have traveled the prescribed distance, unless lower beam headlamps are activated. Lower beam headlamps should automatically reactivate at a prescribed lux value during dark/night conditions. In these vehicles, both the DRLs and lower beam headlamps may not activate under the prescribed conditions when the manual lighting switch is in OFF or PARKING LAMP mode. During that time, the vehicle could be less visible, increasing the risk of a crash.

### Remedy

Dealers will update the software in the vehicles' Body Control Module (BCM) to correct the condition.
